Preamble

“No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury.”

— Fifth Amendment, Constitution for the United States of America

Introduction

We, the People of Bay County, being sovereign and free, do hereby invoke our sacred right and duty to re-establish the **Common Law Grand Jury** in and for this County.

This jury stands as a **fixture of the common law** — older than the Republic itself — serving as the **People’s shield against tyranny** and the lawful **sword against corruption**.

In **U.S. v. Williams, 504 U.S. 36 (1992)**, the Supreme Court affirmed that the grand jury is “a constitutional fixture in its own right,” existing apart from the three branches of government and **belonging to the People themselves**.

Purpose

The Common Law Grand Jury of Bay County is hereby constituted to:

- Guard the unalienable rights of life, liberty, and property.
 - Investigate public corruption and abuses committed under color of law.
 - Provide remedy where justice has been denied or obstructed.
 - Issue **presentments** — the lawful voice of the People — without need of prosecutor or judge.

Authority

This body derives its lawful authority from:

- The **Natural Law** endowed by our Creator.
 - The **Constitution for the United States of America** and the **Bill of Rights**, especially Amendments V, IX, and X.
 - The **Constitution of the State of Michigan**, which secures the rights of the People.
 - The inherent sovereignty of We the People, from whom all just power originates.

Accordingly, on this ____ day of _____, **25**, the People of Bay County, assembled in lawful capacity, do **re-establish and re-constitute** the **Common Law Grand Jury of Bay County**, to exist in perpetuity, renewed by the will of the People and the consent of the governed.
