## Under Absolute Despotism: The Unalienable Right to Throw Off Such Government and Restore Liberty — A Call to Action by the Bay County General Jural Assembly

In a state of sheer despotism, where color-of-law statutes reign instead of legitimate government, and corporate fictions pretending to be legitimate authority supplant the will of the people, the Bay County General Jural Assembly is a moral and lawful bulwark against tyranny. The essential maxims of this Republic declare that whenever a government becomes destructive of the purposes for which it was established—specifically, to secure the unalienable rights of life, liberty, and the pursuit of happiness—the people are not only justified, but are under solemn obligation, to modify or to abolish it and to provide new guaranties for their future security. This is expressed through the replacement of common law courts with administrative tribunals, the invocation of legal fictions to enforce contracts never knowingly entered into, and the routine suppression of assembly, redress, and access to lawful remedy. The people of Bay County, having suffered the long train of abuses and usurpations intended to bring them under absolute corporate despotism, are rising to reassert their original and inherent jurisdiction by forming the Bay County General Jural Assembly and declaring the Sovereign Executive Authority in Trust (SEAT). As in Moses' day before Pharaoh or the colonists before King George, we make this declaration with clarity and resolve: we will no longer consent to be governed by foreign corporations operating under commercial codes offensive to the law of the land and the higher law of our Creator. Our stand is not motivated by partisanship, violence, or chaos, but by truth, righteousness, and the command to love our neighbor by securing liberty for all. It is a spiritual and lawful obligation—a holy resistance to evil clothed in legal disguise. This Assembly does not seek to dismantle government, but to restore lawful governance; not to incite civil unrest, but to re-establish the seat of civil authority where it was always meant to reside—with the people, in their counties, under common law. This sacred duty—to throw off despotism and restore liberty—is not just for our own benefit, but for our children, our posterity, and all who shall come after us. To remain silent in the presence of corruption and tyranny is to permit it; to act is to honor the divine mandate of liberty. Therefore, we stand, lawfully assembled, as the Bay County General Jural Assembly, rejecting the color of law and reaffirming our allegiance to the Constitution for the united States of America and the higher law of the Most High. Let this stand be a trumpet to every county in the land: the time has come to throw off such government, and to reclaim the seat of liberty—locally, lawfully, and unshakably under Heaven's authority.
